# RAPID ALERT REPORT

### Mississippi Non-Fatal Overdoses

For the Month of March 2022

Mississippi non-fatal overdoses in the form of a monthly rapid alert report is an information sharing strategy to help communities reduce illicit and prescription drug misuse. Non-fatal overdose responses in hospital emergency departments and in communities by emergency medical services are reported per public safety district. Monthly thresholds are determined from an average of responses from September 1, 2021 to February 28, 2022. When the number of non-fatal overdoses exceeds the monthly threshold within one standard deviation, the area is highlighted yellow. When the number of non-fatal overdoses exceeds one standard deviation, the area is highlighted red. Public health and public safety partners can review areas which may need additional resources to minimize further drug overdoses.
