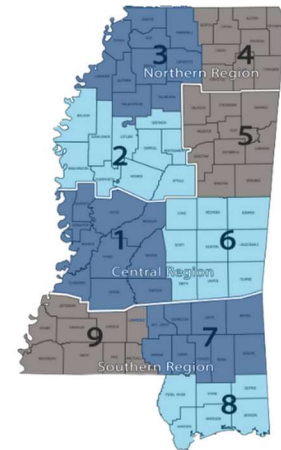
Mississippi Surveillance Overdose System (MS-SOS)

For the Month of August 2022

Mississippi non-fatal overdoses in the form of a monthly rapid alert report is an information sharing strategy to help communities reduce illicit and prescription drug misuse. Non-fatal overdose responses in hospital emergency departments and in communities by emergency medical services are reported per public safety district. Public health and public safety partners can review areas which may need additional resources to minimize further drug overdoses.

NOTES:

- An ED visit or EMS run may treat a patient for more than just one type of drug, so the visit/run is not exclusively counted in just one drug category. Data less than five (5), including zero (0), is suppressed.
- Public Safety Districts highlighted in red have exceeded the pre-established ED and EMS data thresholds and yellow-highlighted regions are equal to pre-established thresholds.
- Emergency Medical Services (EMS) Runs data does not capture stimulants. Column expressed as, "-".
